

# Jenkins Park Advisory Board

## March 22, 2017

### Meeting Minutes

Attendance, members: Bill Bechtel, Dennis Pokrzywka, Lynnette Ziskin.

Town Board Liaison: John Antoski.

The meeting was called to order at 7:07 p.m.

\*Note: this is the 1<sup>st</sup> JPAB meeting in 2017.

1. Due to lack of quorum, the November 30, 2016 meeting minutes were not approved; however, all in attendance agreed the minutes are accurate.
2. Thank you to Woody and Peter for covering the horseshoe poles with the orange cones last November.
3. The rocking pig was broke off its steel spring. The Town Highway Dept. picked it up last fall and will look into its repair (probably welding) Lynnette needs to follow up on this.
4. An agreement was made with Upstate Premier Baseball for use of the baseball field at Jenkins Park. The team has requested to use the field in the spring for their regular season, with the condition that the JPAB commits to eradicating the poison ivy in the area of the field.
5. All members in attendance agreed that Kevin McCarty should be rehired in the spring to eradicate the poison ivy, specifically the perimeter of the back baseball field.
6. Due to lack of quorum, we could not vote to approve to rehire Dan Zappolo for Jenkins Park mowing for 2017. Dan has stated there will be no price increase.
7. Due to lack of quorum, we could not vote to approve Dan Zappolo to remove the downed trees at Jenkins Park.
8. Dan Zappolo will assume the responsibility of split-rail fence repair at the park.
9. Sean Cataldo contacted Lynnette to request use of the field at Jenkins Park for BHU practices every Tuesday in May: 2, 9, 16, 23, and 30. BHU has provided us their insurance certificate. (Again, due to lack of quorum, JPAB could not approve this.)
10. There will be at least one volleyball tournament this summer at Jenkins Park.
11. The Town in Bloom has offered to fund the flowers for Jenkins Park. Lynnette will contact Town in Bloom.
12. Lynnette spoke with Bill Denison, and together they would like to host the 3<sup>rd</sup> Annual Music Festival at Jenkins Park. The date for this event will be announced asap.
13. The Spring Work Party will be on Saturday April 29, 9 a.m. – 1 p.m.
14. The JPAB Annual Meeting will be held in conjunction with our May meeting on Wednesday May 24 at 7:00 p.m. at the Town Hall.
15. Discussion ensued regarding the annual postcard mailing for Jenkins Park. We have a line item in our budget for this.
16. Bill Bechtel provided an up to date accounting report. It was determined that we will have sufficient funds to re-pave the driveway and parking area this year. Lynnette will call Peckham Road Corp for an updated estimate .
17. The next meeting will be April 26, 2017 at 7:00 p.m. at the Town Hall.
