

Jenkins Park Advisory Board
August 18, 2010
Meeting Minutes

Present: Lynnette Ziskin, Bill Bechtel, Jeanrae Benoit, Kim Ireland, Dave Cote, Peter Petrillose, Woody Bowler, Ross MacKinnon.

1. The meeting was called to order at 7:05 p.m. The minutes of the July 14, 2010 were unanimously approved.
2. The JPAB meeting scheduled for September 8 is canceled.
3. Thank you to Woody Bowler for locating Dan of "Uncle Dan's Stump Removal". Dan removed 8 stumps and roots of trees in the park on Friday August 6.
4. Thank you to Woody Bowler, Dan Russell, Dan Richardson, and Ross MacKinnon for your much appreciated help in getting the basketball backboards/rims installed. Thank you Dan Russell for use of his tractor. Also, thank you to Peter Petrillose who loaned his step ladder.
5. Ross MacKinnon is working with Cathy Rogers on a park entrance beautification project, which will be completed in the next couple of weeks.
6. Thank you to Bill Bechtel, Ross MacKinnon and Woody Bowler for removing the old telephone poles in the park. The poles were cut into 25' lengths which will be used for the bridge base soon to be constructed over the West Trail.
7. Thank you to Jeanrae and Marc Benoit for making the necessary repairs to the fire truck climber on our playground. The fire truck will be painted this week by 2 high school volunteers.
8. Due to low enrollment, the volleyball camp scheduled to be held at Jenkins Park was cancelled. However, the Pop Warner football kick-off celebration was held August 14 at Jenkins Park.
9. Bill Bechtel gave an update on park funding through July.
10. Thank you to Woody Bowler and Ross MacKinnon for creating the Jenkins Park usage forms. The JPAB continues to discuss instituting a Park Use Permit (application) and a Rules of Use Form. Kim Ireland will check into the insurance and liability questions that were raised in our discussion. In the near future (after unanimous approval by the JPAB and the Town Board), the procedure will be posted on the TOB website.

11. We are discussing the need for a fall work party. We will set a date at our October meeting.
12. Thank you to Bill Bechtel for his time and efforts in preparing the 2011 Jenkins Park proposed budget. After some discussion, a few minor changes will be made to the budget he has prepared. All were in agreement to schedule another meeting for next Wednesday, August 25 at 7:00 p.m. We will meet at Jenkins Park to vote for the approval of the 2011 Jenkins Park proposed budget. We will also select the best location for the horseshoe pits which will be installed this fall.
