

## **Jenkins Park Advisory Board (JPAB) Minutes of Meeting on February 9, 2010**

Chair Lynnette Ziskin opened the meeting at 7:05 p.m.

Member of the Board in Attendance: Lynnette Ziskin, Dave Cote, Bill Bechtel and Dan Richardson.

Others in Attendance: Town Board members Kim Ireland and Tim Szczepaniak.

1. Since a voting quorum was not in attendance a vote for approval of January 12, 2010 meeting minutes could not be made. Minutes were reviewed however.
2. A review of the post cards to be sent to all Jenkins Park District homes was made. These are the upcoming important events for the park:
  - Annual Meeting on Tuesday March 16 at 7:00 p.m. Sewell Room, Town Hall.
  - Trail Cutting Party on Saturday March 27, 9:00 – noon.
  - Annual raking/clean-up party on Saturday April 17 (rain date, Sunday April 18).
3. Tentatively set for Saturday March 20 is a walk of the park boundary with Dennis P.
4. Ross MacKinnon is to be recommended as a JPAB alternate for approval by the Town Board.
5. County Waste delivered two trashcans in early February. Lynnette proposed to purchase two signs with the wording: "Warning, No Dumping, Violators Will Be Prosecuted".
6. Lynnette listed these projects for 2010:
  - Basketball area: Repairs necessary: fix hoops, install new nets and paint backboards.
  - Future Boy Scout projects: bike rack and west trail bridge.
  - Repairs must be made to the fire truck climber.
  - Remove 3 slanting trees, 6+ stumps, and add topsoil in playground area of park.
  - Remove (at least 2) old dangerous telephone poles.
  - Grass carp as an initial method of cleaning the ponds.
  - Remove some of the back sections of the field # 2 baseball fence and increase the sledding hill.
  - The baseball group to paint/repair backstop on field # 2 in the spring.
  - Free stone dust acquired for West Trail.

  - New Projects
  - How we spent funds in 2009
  - How we will spend funds in 2010
  - Pond rehabilitation methods
8. A short discussion ensued on how to get the word out to people outside the park district. Suggestions were putting an article in the Spotlight, Community News, Daily Gazette, Saratogian and Town website.
